**Self Injection:** Accidental self injection may lead to an inflammatory response. Strong squeezing of the site should be avoided. The damaged area should be thoroughly cleansed and a topical antiseptic applied. Check your tetanus immunisation status.

## SECTION 6 - ACCIDENTAL RELEASE MEASURES

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern.
